

## Looking for a Place to Leave a Legacy

Legacy gifts reveal our faith to our community as a witness of God's great love for us. They are a final testament of what you value as a Catholic. To that end, the Catholic Community Foundation (CCF) assists families and individuals in creating their legacy giving that support the work of the Church.

### Gifts in Your Will

Without a will, the state may distribute your assets in ways that do not meet your family's needs or reflect your Catholic values.

Naming the Church as a beneficiary in your will is the easiest and most popular ways to provide lasting support for your parish, school, ministry or the CCF.

You can structure your will to leave a dollar amount or a percentage of your estate. Just a few sentences in your will are all that is needed, and you can modify your legacy gift at any time.

### Gifts of Property

Gifts of appreciated real estate such as your home or vacation property, and securities can be another source of your gift to the Church and may reduce estate taxes to your heirs at the time of your death.

It is important to discuss these options with the your advisor before writing your will.

### Life Insurance & Retirement Accounts

A Life Insurance policy is another way to make a sizeable gift to the Church.

It is as simple as asking your insurance company to for a beneficiary form. You can leave a specific percentage to your parish, school, ministry or the CCF. For example: You can leave 25% to your parish, 25% to the CCF and 50% to your family.

Did you know that many retirement accounts such as an IRA or 401K can be heavily taxed when left to family but can be tax-free when you designated an entity of the Diocese of Richmond to receive it upon our death? By contacting your plan administrator and making a beneficiary change, you can leave a legacy that supports the Church.

Catholic stewardship, giving back to God for the gifts we have been given is the ultimate act of faith. The CCF offers a wide variety of legacy giving opportunities that provide long-term, sustainable support for the parishes, schools and ministries of our Diocese.
