Benefits of a DAF

You will receive an immediate tax deduction for the maximum amount allowed by law, but you do not have to decide now which ministries or other organizations in the Diocese of Richmond you wish to support. You can take the time you need to recommend grants, and add to your fund at any time.

How to Get Started:

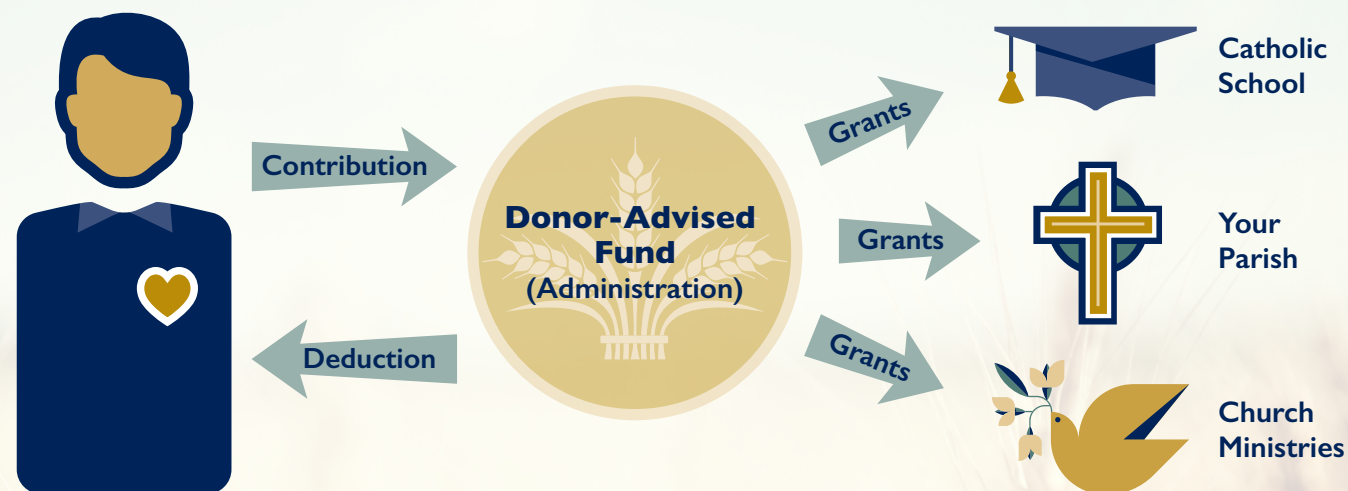
- Complete the DAF Agreement.
- Contribute assets of at least \$25,000.
- Recommend grants from your DAF to parishes, schools, ministries or CCF funds.

How a Donor-Advised Fund Works



Contribution

You make an irrevocable contribution of assets.

Deduction

You receive an immediate tax deduction, the maximum allowed by the IRS.

Administration

You name your Donor-advised Fund account, advisors, and successors and ultimate charitable beneficiaries. CCF places your contribution in a Donor-advised Fund account. It is invested and grows tax-free.

Grantmaking

You recommend grants from your DAF account to qualified charities, at a time and on a schedule of your choosing.*



Leave a Lasting Legacy

Similar to a family foundation, but without some of its complications, you can ensure that granting continues after your lifetime by naming a successor to take your place as grant advisor. You also have the option, when setting up your DAF, to designate an ultimate gift of the remainder of your DAF to a parish, school or Catholic organization of the Diocese, or to create a permanent endowment.
